

# THE CAMPAIGN TO BUILD AND ENDOW PROVIDENCE CHAPEL



## Our Journey...

Baptist Homes Society has always pursued a course of excellent care, benevolence and Christian compassion. Beginning in 1910 with a mission to serve widows and orphans, we transitioned into a distinctive continuing care retirement community that offers a fulfilling lifestyle for nearly 750 seniors at our Baptist Homes and Providence Point campuses in Mt. Lebanon and Scott Township, respectively. Baptist Homes Foundation is the fundraising entity that generates support for and promotes our mission.

In response to increasing demand for services at our Providence Point campus, we are embarking on the final phase of the project: to build 70 additional units and a chapel. The new apartments will cost \$42 million to construct. It will cost \$3.5 million to build the chapel and endow our chaplaincy program. ***Since public financing cannot be used to construct or endow the chapel, we need your help, and here's why:***

### The Case for Support

#### Why build a chapel at Providence Point?


Providence Point is a senior living community developed by Baptist Homes Society to further our mission, which is to provide the highest quality of living for those we serve, while uplifting one person at a time. As a faith-based organization with a 107-year history, we are called to express Christian love for all and to be a witness to God's love, especially to those entrusted to our care, regardless of their personal beliefs or religious affiliations.

One of our core values is to affirm the right of all individuals in all of our communities to achieve their highest level of well-being in mind, body and spirit. We are committed to providing an environment that encourages and supports the components of physical, emotional, spiritual, social, intellectual, and community wellness.

Through this campaign, we will raise \$3.5 million in private contributions to construct a chapel that considers the faith traditions of all of Providence Point residents and endows the Baptist Homes Society chaplaincy program, assuring that the spiritual needs of all entrusted to our care can be met in perpetuity.



## How will Providence Chapel enhance the lives of those we serve and our community?

- Providence Chapel will accommodate at least 100 persons, providing a space for residents to gather privately or collectively for religious services regardless of the denomination;
- Providence Chapel will provide a place for memorial services and religious programs;
- Providence Chapel will provide a venue for weddings and funerals;
- Providence Chapel will be designed to serve as a multi-purpose space for appropriate non-religious services, assuring maximum use of the area;
- Providence Chapel will incorporate 123-year old historic stained glass windows into its design, preserving a regional piece of Baptist Church history, while applying an adaptive reuse to an art-related treasure;
- Providence Chapel will provide a way for donors to memorialize loved ones through recognition tied to their support of the campaign.

## Ways to Give

### Make us an Irrevocable Beneficiary of an Entry Fee Refund

Providence Point residents [or other CCRC residents] can irrevocably direct a portion of their refundable entry fee to support this campaign.

### Make us an Irrevocable Beneficiary of an Existing Charitable Trust

If you have a charitable trust, you can make **Baptist Homes Foundation** an immediate irrevocable beneficiary of that trust.

### Gifts of Mineral Rights

Donate non-operating mineral interests to **Baptist Homes Foundation** and claim a tax deduction based on the mineral interest's fair-market value at the time of the gift.

### Gifts from a Will or Living Trust

If you need to preserve your assets during your lifetime, this gift will only take effect after your other obligations are fulfilled. While there's no immediate tax benefit associated with this gift, it can provide funds for our endowment to underwrite the future cost of care for residents who deplete their assets through no fault of their own.

### Stocks, Bonds or Mutual Fund Shares

### Whole and Variable Life Insurance

You transfer ownership of a paid life insurance policy to **Baptist Homes Foundation** who can elect to cash in the policy now or hold it.

Make an outright gift from your donor-advised fund OR name us the ultimate beneficiary of the remainder in the fund.

### Gifts from Traditional IRAs

If you're at least 70 1/2, you can transfer up to \$100,000 directly to **Baptist Homes Society** without incurring federal income tax and the gift counts toward your required minimum distribution.

### Appreciated Property or Real Estate

You deed your home, vacation home, undeveloped property, or commercial building to **Baptist Homes Foundation**. You may continue to use the property rent-free, and then ownership passes to us when you no longer need it. Baptist Homes Foundation may use the property or sell it and use the proceeds.



## Why does this campaign have an endowment component?

Generally speaking, an endowment is a permanent fund where the principal is kept intact and from which income and gains are used for a specific purpose in perpetuity. By creating a chaplaincy endowment, Baptist Homes Society assures that moving forward it will have the funds needed to provide spiritual programming and maintain and staff the chapel on both campuses even in the event of uncertain economic conditions.

## Feasibility

- More than one-half of the campaign goal has already been committed by donors.
- Providence Point residents have expressed overwhelming support for building a chapel on that campus reflective of the religious make-up of the community. Some residents have even made irrevocable pledges of some or all of their entry fee to assure construction and endowment of the chapel (see [Ways to Give](#)).



- All of our board members have collectively contributed nearly \$150,000 to the capital campaign to enable Baptist Homes Foundation to receive a \$50,000 challenge grant.
- The region has recognized the historic significance of the 123-year-old stained glass windows being incorporated into the project and The Allegheny Foundation has awarded a \$25,000 grant to restore the windows and a \$70,000 grant to incorporate six contemporary windows with the historic design.

- Funds irrevocably committed to the project may have qualified as collateral for a low-interest private loan that permitted construction of Providence Chapel to begin before the Phase II expansion of Providence Point and reduce construction costs.
- Operating funds currently being directed to offset the cost of Baptist Homes Society’s chaplaincy program will be permanently redirected to our Samaritan Fund for Resident Assistance to help to subsidize the care of residents who have outlived their resources [Baptist Homes Society currently provides nearly \$4 million annually in benevolent and reimbursed care].


### Principal Outcome

To give honor and glory to God by our service to those entrusted to our care.

### Budget and Construction

The net cost to build Providence Chapel is estimated to be \$1.5 million [refer to the chart on the next page]. The \$2 million endowment is projected to generate \$100,000 annually in perpetuity to cover chapel-related maintenance and upkeep costs on both campuses, the cost of our chaplain, visiting ministers, and other costs related to our chaplaincy program.

Construction began in the summer 2017. Completion is scheduled for early 2018.



### Builders and Endowers

- Gifts and pledges from \$3,000 to \$24,999 will be acknowledged on our *Builders Board*.
- Gifts of \$25,000 and up will be acknowledged on our *Endowers Board*.
- Persons contributing \$25,000 or more will have the option of being listed on the *Endowers Board* or having their name or the name of a loved one integrated into one of the six contemporary 30 inch by ten-foot stained glass windows being made for Providence Chapel, on a first come, first served basis.

### Pledges and Recognition Criteria


To encourage maximum participation, pledges may be paid over three years. Revocable gifts, such as bequests, will only be recognized when payment is received.

Irrevocable planned gifts, such as trusts and gift annuities, will be recognized based on the present value of the projected charitable remainder amount.

Gifts of tangible personal property and real property will be recognized at their value as determined by a third-party certified, qualified appraiser.



## Moving Forward Without Forgetting our Past

*The centerpiece of Providence Chapel will be three 1894 stained glass windows made by the preeminent glass maker Rudy Bros. & Reich of Pittsburgh for Mansfield Baptist Church in Carnegie, PA and rescued in the mid-20th century. The windows were donated by Mardi and Larry Jackley at our campaign kickoff on August 31, 2016. Given their artistic and historic significance, a grant has been provided by The Allegheny Foundation to restore the windows.*

*Ironically, Albert M. Tannler, a nationally recognized authority on Rudy Bros. & Reich stained glass and John Kelly, a prominent restorer of Rudy Bros. & Reich stained glass, are both based in Pittsburgh. Acquisition and restoration of these windows for Providence Chapel assures that these treasures will continue to be enjoyed by future generations. Six new stained glass windows are being designed to complement the centerpiece.*
